### **MINUTES**

1. Call to Order

The meeting was called to order at 7:03pm.

2. Community input

The amenities committee was addressed by Jordan Johnson, a 2-year resident of Firethorne. He would like to see backstop installed so fields are available for softball / baseball teams to practice. His child plays softball. He stated that he would be open to a rental fee or a reservation system and believes one player on the team being a resident should be sufficient representation to reserve the field for a team. A team practice schedule is usually twice a week for two hours. The team roster is 10 to 13 players.

  - Note that an authority / peace officer might be needed if a new reservation system goes into effect.
  - Need new signage to update rules. Therese and Noah to meet separately.

  - Therese identified additional chair options and ordered fabric options available from the chair company.
- g. 2025 Wood Lily project update
  - Therese has a contractor coming out to look at bidding the entire job.
  - Kristen will get additional sidewalk bids.
